The U.S. National Committee on Vital and Health Statistics was established in 1948 at the request of the Department of State in accordance with recommendations of the First World Health Assembly to advise on matters relating to vital and health statistics and to promote and secure technical developments in this field.

Specifically the functions of the National Committee are to:

Delineate statistical problems of public health importance which are of national or international interest;

Stimulate studies of such problems by other organizations and agencies whenever possible, or make investigations of such problems through subcommittees appointed for the purpose;

Review findings submitted by other organizations and agencies or by its subcommittees, and make recommendations for national and/or international adoption;

Cooperate with and advise other organizations on matters relating to vital and health statistics in the United States especially with reference to definitions, statistical standards, and measurement problems;

Advise on problems relating to vital and health statistics of national and international concern; and

Cooperate with national committees of other countries and with the World Health Organization and other international agencies in the study of problems of mutual interest.

ACTIVITIES DURING FISCAL YEAR 1972

The U.S. National Committee on Vital and Health Statistics stepped up its preparatory activities during fiscal year 1972 for the Ninth Revision of the International Classification of Diseases. Present plans include the submission of proposals to the World Health Organization in late 1972. The Uniform Hospital Abstract Form Subcommittee submitted its final report to the National Committee. The Financial Data Year Planning Subcommittee's activities have been devoted to obtaining information about the uncoordinated sets of financial data on health services that are now being collected by various governmental agencies and private organizations.

The Subcommittee on the Ninth Revision of the International Classification of Diseases has been concerned with drafting proposals for submission to the World Health Organization (WHO) in the areas of infective and parasitic diseases; endocrine, nutritional, and metabolic diseases; mental disorders; malignant neoplasms; diseases of the circulatory system; diseases of the skin and subcutaneous tissue; and sudden infant death syndrome. Recommendations in these areas will be submitted to WHO in the early fall of 1972. Draft proposals are also being developed in the areas of diseases of the digestive system; diseases of the respiratory system; complications of pregnancy, childbirth, and the puerperium; diseases of the musculoskeletal system and connective tissue; congenital anomalies; and accidents, poisonings, and violence.

The Subcommittee has discussed the need of and expectations from a classification of environmental and social factors causing or affecting disease. Hospitals, outpatient departments, and other health-care systems concerned with morbidity are particularly in need of some way to classify the problems which patients present. While these are often not diseases, they are conditions that need treatment, and these conditions have to be accounted for.

The Subcommittee on Financial Data Year Planning devoted most of its efforts to obtaining information about the uncoordinated sets of financial data on health services that are now being collected by various government agencies and private organizations. This information is pertinent to each of the responsibilities assigned to the Subcommittee. The draft report of the Subcommittee has been delayed because of the need to rethink certain issues facing the Subcommittee, mainly in the area of techniques for measuring the effects of changes in public policy, and the need to take advantage of information on changes now being made by the U.S. Bureau of Labor Statistics in the medical components of the Consumer Price Index.

The final report of the Uniform Hospital Abstract Form Subcommittee was accepted by the National Committee for publication as a Committee document. The Subcommittee will be on a standby basis pending completion of the field tests (now being carried out in six areas) to allow for any necessary revisions in the future.

In its final report, the Subcommittee recommended that three items be dropped from the tentative minimum basic data set. "Marital status" (with living arrangements) was suggested for inclusion in the basic data set as affecting ease of discharge of specific patients. This item was considered less suitable for the stated purpose because it provides information only with respect to legal status of the patients, which differs from living arrangement in many instances for many different reasons. "Service to which admitted" in larger hospitals is classified for internal administrative purposes by site within the facility where care is rendered. Some abstracting systems record the service to which the patient was admitted and have the further capability of reflecting transfers within the institution and allocation of time spent during a particular admission. These are considered desirable options but not at this time to be considered essential items for a basic data set. "Total charges" was the only data set which is not routinely available in the medical records department of the typical hospital and which would, if included, duplicate the information available from the projected concomitant billing form. Since it was felt that a primary purpose of the basic data set was to provide a means by which to furnish accurate information to support a claim for payment and that it would also have a number of other uses, the inclusion of the total charge for the hospital stay on the discharge abstract appeared to be an unnecessary duplication.

The National Conference on Ambulatory Medical Care Records (sponsored by the National Center for Health Services Research and Development, the National Center for Health Statistics, and the Johns Hopkins University) held in Chicago, April 18-22, 1972, recommended that the U.S. National Committee on Vital and Health Statistics establish a panel and one or more task forces "...to determine the content, terms, definitions, classification schemes and codes to be employed and to consider problems of maintaining reliability and of legitimizing the use of the basic data set" for data on patients, providers, and services in ambulatory services. The National Committee accepted this responsibility and authorized the formation of a technical consultant panel to be concerned with the technical questions of data items, definitions, and classifications.

A draft charge for a proposed technical consultant panel concerned with social indicators was reviewed. The Committee agreed that the responsibilities of this panel should not be restricted entirely to health

indicators. However, its emphasis should be on health indicators and other indicators related to health. Mr. Robert Parke, Jr., whose term on the National Committee expired this year, agreed to accept chairmanship of the panel.

The National Committee reviewed a charge for a panel on needed statistics and statistical data systems for formulation of a national population policy. The charge was discussed in relation to research recommendations in the report of the Commission on Population Growth and the American Future. The Committee recommended that the charge to the panel be more limited in scope and more specific and emphasize the kinds of analyses of data that are needed. When revised, the charge will be circulated to members of the Committee for final approval and a technical consultant panel will be established.

Establishment of a panel with responsibility for developing a proposal for analytic activity within the National Center for Health Statistics to include a statement on policy, organization and staffing pattern, development of analytic techniques, and provision of technical assistance was authorized.

The World Health Organization has planned a second international conference of national committees to be held in October 1973; location has not yet been determined. The U.S. National Committee on Vital and Health Statistics has offered to assist in the planning of this conference.
